### Important update to the Scheme

An important change to the Baptist Union Superannuation Scheme has occurred. Vesting of the employer contributions has been removed from the Scheme.

We contacted all members to ask for their votes on this change. We're pleased to share that we received 100% approval from members to remove the vesting provision. The Trustee Directors and the Assembly Council approved the change. It became effective in June 2024.

This means that in all cases (except in one minor situation), when you leave the Scheme, you will now receive 100% of the contributions your employer made on your behalf—no matter how long you've been a member.

#### Annual returns and member statements available

The Baptist Union Superannuation Scheme has announced its annual return for the period ended 30 June 2024.

The Scheme delivered a return of 9.69% for the past scheme year. This result reflects the performance of the Scheme's investments over that period. As always, returns are influenced by market conditions and investment strategy. Remember, while past performance gives insight, it doesn't guarantee future returns.

# New feature: View interim rates on the website

We've added a helpful feature to the Baptist Union Superannuation Scheme *website* (buss.org.nz). You can now view the interim rate in the site's performance section. The Scheme calculates the interim rate monthly, giving you a snapshot of how your investment performs throughout the year.

Here's how it works:

- The interim rate is updated monthly and is visible on the website.
- When you log into your member area, you can see how the interim rate would impact your balance if you made a full withdrawal.
- Please note that interim rates are not applied to partial withdrawals.

This feature is handy for retired members who no longer contribute and would previously see the same balance until the annual return was applied. Now, you can track your investment performance in real-time.

# Keeping your details up to date

It's important to keep your contact details up to date with us if you change where you are living, your phone

number or your email. We send out your annual member statement, annual reports, important information about changes to the Scheme which might impact members and these newsletters using your current contact details.

Often, when a new member joins, they use the details of their church as their contact details. If they leave that church and do not update us we could lose touch with them. If you want to make a change to your contact details you can email, post or update your details in your member area of the website.
